

SustainaWOOL Integrity Scheme - Audit Checklist

This document details the audit requirements applicable for SustainaWOOL Integrity Scheme growers completing the current SustainaWOOL Grower Declaration (v6.0).

Growers seeking SustainaWOOL certification are required to have read and understood the implication of the Auditor Checklist prior to completion of the SustainaWOOL Grower Declaration, and are provided with a copy prior to any farm inspection. SustainaWOOL Audit Checklists are always accessible at <http://sustainawool.com.au/>.

Farm audit principles applied

1. **SustainaWOOL farm audits are conducted in such a way as to maximise detection of non-compliance, and maximise cost-efficiency for scheme participants.**

The conduct of physical inspections to verify compliance is critical to any integrity scheme, and is also a major source of cost to scheme participants. For this reason, many schemes operate on the basis of a **proportional sampling approach**, whereby a subset of participants are audited within a given timeframe (e.g. each year) - this allows for a robust performance verification to occur, while reducing the often substantial compliance costs which could otherwise be a barrier to participation.

Like other schemes, **SustainaWOOL offers growers 2 levels of audit intensity:**

1. **Individual Certification** - where each farm is audited each year (100% chance of audit each year). This level of integrity is a requirement for SustainaWOOL **GOLD** members.
2. **Group Certification** - where farm audits are randomly allocated to a proportion of farms each year (20% chance of audit each year on average). This average level of audit intensity is a requirement for SustainaWOOL **BLUE** or **GREEN** members.

However, while on average 20% of farms are audited each year for SustainaWOOL Group Certification members, we recognise that it is critical to ensure that non-compliance issues are identified as soon as possible when a member joins the scheme. For this reason, we apply a stratification based on the length of membership tenure, so that new members have a 55% chance of inspection in Year 1, and 25% in Year 2 - so that there is an 80% chance of a farm audit being conducted within the first 2 years of a membership, while retaining a 20% chance on average over 5 years. After 5 years of membership, the stratification is removed so that the audit intensity becomes 20% each year thereafter.

This SustainaWOOL approach achieves an excellent balance of audit intensity and statistical efficiency, and is directly comparable to that being applied in other major certification standards. For example:

- The Responsible Wool Standard Group Certification approach accepts farm audit allocation at the rate of the square root of the number of group members, plus one. So, for typical farm group sizes (25 - 100 members), audit intensity would range from 11 to 24% per year.
- The ZQ standard conducts independent farm inspections of a 3-year rotation, so approximately 33% per year.

2. **SustainaWOOL farm audits are conducted to internationally recognised integrity standards.**

AWEX has achieved certification under ISO9001:2015 for provision of independent quality assurance services to the Australian and international wool supply chain through the SustainaWOOL Integrity Scheme and the National Wool Declaration Integrity Program. These audits are conducted synergistically, for maximum cost-efficiency.

3. **SustainaWOOL farm audits are only conducted by qualified and experienced industry specialists.**

SustainaWOOL auditors are not 'green behind the ears' - each has deep experience in sheep agriculture and in conduct of farm audits.

The SustainaWOOL farm audit process

1. Individual SustainaWOOL members are identified for inspection using a stratified random allocation methodology, certification level (Individual or Group) and their prior inspection history.
2. AWEX farm inspectors group allocated inspections into regional 'runs', and contact farmers to arrange inspections. While the specific timing of the inspections can be negotiated, inspections cannot be refused by growers wishing to maintain their certification.
3. Once an inspection date and time is agreed, AWEX issues the grower a formal notice of inspection, and provides the grower and inspection a copy of the existing Grower Declaration, and copy of the applicable Audit Checklist.
4. The audit is conducted, and usually takes 2 - 3 hours to complete. The inspection will typically involve inspection of premises such as shearing sheds, chemical stores and yards, inspection of records, and inspection of groups of sheep and sections of the farm - so as to ensure compliance with the SustainaWOOL Grower Declaration.
5. At the conclusion of the inspection, the auditor will complete the audit report and discuss with the grower audit findings and outcomes. The grower is thereafter issued with a formal Audit Compliance Report by AWEX.

Audit outcomes

The following table outlines the possible audit outcomes, and the consequences for SustainaWOOL growers.

B. ABBREVIATIONS, DEFINITIONS & NOTES

- * **Authorised Auditor** = Auditor(s) chosen by AWEX Ltd for the SustainaWOOL Integrity Scheme.

- * **AWEX** = The Australian Wool Exchange Ltd.
- * **Body Condition Score** = The practice of hand assessment of the cover of fat and muscle tissue along the backbone and ends of the short ribs. It is scored on a scale of 1 to 5, with 1 being emaciated and 5 obese. Sheep in the flock should range from 2 - 4, and breeding ewe BCS should be BCS of 3 or above for joining, mid-pregnancy, and at lambing.
- * **Mulesing** = The removal of skin from the breech and/or tail of a sheep using mulesing shears.
- * **Alternative Procedures** = An alternative procedure for modifying the breech of sheep for the purposes of reducing blow fly strike risk or stain and contamination, comprising Sheep Freeze Branding (cryosurgery), or application of constrictive mechanical clips.
- * **Corrective actions** may include (but are not limited to):
